- Silverton Public Library \$11,500 for new computers; competitive
- Town of Dolores \$5,000 for Dolores bike and skate park and path; regional merit

Founded by Spencer and Julie Penrose in 1937, El Pomar Foundation has an established legacy of general-purpose grant making. The competitive process remains the Foundation's primary vehicle for organizations to receive funding. Additionally, over the last 88 years, El Pomar has either developed or been entrusted with the stewardship of a number of other funds, as well as presenting merit grants in each region recommended by Trustees and regional council members. Competitive applications are accepted on a rolling basis.

In an effort to increase impact and establish connections across the entire state, the Regional Partnerships program was established in 2003. Each of the Foundation's eleven regional councils advises El Pomar Trustees and recommends grants to help support its communities. The Southwest Regional Council recommends grants to Archuleta, Dolores, La Plata, Montezuma, and San Juan Counties. Council members are regional leaders in the business, nonprofit, and public sectors and provide first-hand information about current needs in their own communities.
